Facility Tour Release and Waiver of Liability

2. I hereby confirm that I am in adequate physical condition to participate in the tour, which may involve, among other physical activities, walking up stairways or over uneven floors.
3. I, for myself, and on behalf of my heirs, assigns, representatives and next of kin, hereby unconditionally waive and fully release, indemnify and hold harmless Winnebago Industries, Inc. and its Winnebago subsidiaries from and against any and all claims, demands, actions, causes of actions, suits, damages, losses and liability arising out of or related to the tour, including any personal injury, disability or death I may suffer, or loss or damage to personal property, except to the extent attributable to the gross negligence or willful misconduct of Winnebago Industries. I understand my release and obligation or indemnify and hold Winnebago Industries harmless applies even if Winnebago Industries is negligent.
